

SISTER CIRCLE “MY LOVE STORY” CONTEST OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the **SISTER CIRCLE “MY LOVE STORY” CONTEST** (the “Contest”) is open to legal U.S. residents (excluding Puerto Rico) who are 18 years or older at the time of entry. Limit one (1) entry per person.

Judges will base decisions on creativity (1/3 weighing), compelling nature of group (1/3 weighing) and visual presentation (1/3 weighing). The ratings scale for each criterion will range from one (1) to twenty (20), with twenty (20) being the best score. The three (3) eligible entrants with the highest cumulative scores will be named the Finalists. In the event of a tie, tied entries will be re-judged on the same criteria listed above. On or about Thursday, February 14, 2019 the finalists will be posted on the official Sister Circle Live social media pages and winner will be selected by online poll active from the time of posting until 11:59 p.m. (E.T.) on Sunday, February 17, 2019. In the event of a tied poll result, the winner will be selected by a random drawing from among the tied finalists.
5. **Prizes.** The Prize is one gift card (**ARV \$250**). Odds of winning depend on skill of entrants and the number of eligible entries received.
6. **Winner Notification and Acceptance.** Winners will be notified on or about **FEBRUARY 18, 2019 via email and on-air**. Winner must respond to the email notification within **24** hours of the date and time on the email. Failure to respond within such time period, return of email prize notification as undeliverable or failure of winner to respond to the email notification may result in disqualification and an alternate winner may be selected from among all remaining eligible entries.
